3. Shield - it's a communications program on major areas such as terrorism. It eliminates the 10 codes previously used by departments. It has National and Global participants exchanging information

4. Project 1st Responder - allows people to register with communication difficulty's, memory issues, wanderers etc.
5. Dept Chaplains – they talk with people who pose dangers to themselves or others and give an ear to deputies who have seen horrible things while on calls.

6. Child seat instructions

7. Middle school program - work with younger people because today's day and age make police to look like the bad guys and they become afraid of police.

PROGRAM

In my recent articles in the newsletter, I have spoken about Global Warming and other weather-related items. But this time, I must express the thanks that should come from us Louisa County and Virginia residents. So many of our fellow countrymen have been suffering from a range of extreme conditions – tornadoes, flooding, baseball-size hail, extreme wind conditions, etc. etc.

Our April program was especially good, with our speaker Sergeant Chuck Love of the LC Sherriff's Office who serves as their Public Information Officer and coordinator of much of their outreach to the community. He covered the current LCSO programs: animal control, apps and alerts, law enforcement academy and adventure program, chaplain corps, LCSO Foundation, project lifesaver, and the many youth programs and benefits. Of particular note was their SHIELD Program, a communityfocused policing method to counter crime, threats, and even terrorism by engaging community members and partners. In addition, we had extended invitations to the community's American Legion and VFW organizations to join us for lunch and the presentation, which resulted in about 10 more attendees than usual.

The program for the upcoming June meeting will be "Part II" of a story we first heard about at our February meeting last year. The topic began 10 years ago when our Chapter 2065 member Bob Maher and his fellow members of Sts Peter and Paul Knights of Columbus Council in Palmyra created the St Francis of Assisi Health Clinic in Uganda. This presentation will be given by Jamie Hicks of Palmyra, who serves as a Nurse Practitioner in the NICU unit at UVA Hospital. She was in Uganda for two weeks in January teaching their doctors and nurses how to treat and save newborns who are born in distress. And as we did last year to recognize the good work of the Palmyra KofC, we are inviting the local St. Jude Council members to attend.

Regarding future programs this Fall, we will have a medical insurance expert to provide guidance on changes to the system and particular information for Federal retirees. We are always appreciative of any ideas or suggestions you may have, and in the meantime, stay safe from the many severe weather situations passing through the country!

<u>NATIONAL LEGISLATION REPORT</u> Current Fiscal Year (FY)2024

Right after we prepared the March Legislative Report, the FY 2024 Appropriation Bills were passed:

• On March 9, 2024, the President signed into law: H.R. 4366, the "Consolidated Appropriations Act, 2024," which provides full-year funding through September 30, 2024, for 6 of 12 appropriations bills.

• FY2024 Further Consolidated Appropriations Act H.R. 2882 was signed into law on March 23, 2024, which provides full-year funding for the rest of the appropriation bills.

Next FY2025 which starts October 1, 2024

Congress is already clashing on FY25 funding as House proposes big cuts with Republicans looking to ignore a deal Biden struck with them last year while Democrats are seeking increases for federal agencies.

- House Republicans are proposing an average of 6% discretionary spending cuts to non-defense agencies for fiscal 2025, putting it on a collision course with the Democratic-led Senate that is seeking to avoid such reductions.
- Republicans on the House Appropriations Committee released their top-line spending levels for each of the 12 annual funding bills Congress must pass each year, which included cuts for some agencies as high as 11%.
- The appropriators are putting aside parts of the two-year budget deal President Biden struck with House Republicans last year in exchange for raising the debt ceiling, saying they are instead sticking only to the spending levels detailed in the Fiscal Responsibility Act. In addition to that law, Biden and then-House Speaker Kevin McCarthy, R-Calif., agreed to other mechanisms that would ultimately allow both defense

and non-defense discretionary spending to increase by 1% in fiscal 2025.

- The bills written by [the House Appropriations] Committee will adhere to law set by the Fiscal Responsibility Act—with no side deals—and focus resources where they are needed most. The FY25 process will reflect the committee's commitment to strengthening national defense, supporting the safety and security of the American people and reining in government to its core mission.
- Under these proposals, the departments of Labor, Health and Human Services, Education, Treasury, State and related agencies would all receive cuts between 10% and 11%. The Pentagon would receive a 1% boost, while the Homeland Security Department would receive a bump above President Biden's request and the Veterans Affairs Department would see its request met. The appropriations committee is set to begin marking up its fiscal 2025 bills next week.
- Democrats were ready to negotiate but said Congress must meet its prior agreement and ensure defense and non-defense funding both see increases of at least 1%.
- The Senate Appropriations Committee chair has said Democrats will not accept any spending bills that do not provide parity in the funding boosts to defense and nondefense accounts.

The following are updates on items that we have been keeping track of:

Social Security Fairness Act of 2023 H.R. 82 and S. 597 – Co-sponsors has increased to 319_in the house (208 Democrats, 111 Republicans) and 53 in the senate (41 democrats, 9 republicans and 3 independents).

- This bill eliminates the Windfall Elimination Provision (WEP) which reduces Social Security benefits for individuals who also receive a pension or disability benefit from an employer that did not withhold Social Security taxes and the Government Pension Offset (GPO) which reduces Social Security benefits for spouses, widows, and widowers who also receive government pensions of their own.
- This is the most support that a Social Security Fairness Act has gotten in any congress.

The other bills related to Social Security are H.R.4583/S.2280-Social Security 2100 Act which has 184 democratic co-sponsors in the House and 4 in the Senate.

- This modifies the Social Security system with respect to benefit calculations, fund administration, and beneficiary resources.
- The bill temporarily increases the primary insurance amount for Social Security benefits for all individuals. It also modifies benefit calculations for certain individuals, including temporarily (1) increasing benefits for widows or widowers in two-income households; and (2) allowing children of a deceased, disabled, or retired worker to remain eligible for benefits through age 25 if they are full-time students (Currently child benefits end at age 18 or when the recipient finishes high school).
- The bill temporarily eliminates the *GPO* and WEP.
- The bill also modifies the financing and administration of the Social Security trust funds by (1) subjecting income over \$400,000 to Social Security payroll taxes, and (2) combines the Federal Old-Age and Survivors Insurance Trust Fund and the Federal Disability Insurance Trust Fund into a single Social Security Trust Fund

The 2024 Social Security Trustees Report released on May 11, 2024, revealed a slightly improved outlook for the program. A year ago, the government thought benefit cuts would be necessary in 2034. Now, the Social Security Administration expects to fund all scheduled benefits through 2035, and the estimated funding shortfall after that point will be less than previously thought too.

As welcomed as that news is, the fact remains that Social Security cannot continue in its current form for long. Action of some sort -- to increase funding, reduce benefits, or both -- needs to happen, and the longer the government puts it off, the more difficult it's going to be for workers and seniors.

Consider going to the advocacy page of the NARFE.org website where there are prepared letters on some of the topics discussed above or that are important to federal employees/retirees. You can write your own letter/e-mail and they will ensure that it is sent to your representative and senators plus notify you that the e-mail was sent. NARFE also gives you the ability to send comments to your representative and senator using Twitter ("X") if that is your preference.

These topics include Saving the Civil Service Act, Long Term Care Premiums, Equal COLA, etc.

VIRGINIA LEGISLATION REPORT

Hurray for Virginia, this is how collaboration and compromise begin.

- * Lawmakers agreed on a budget, and Gov. Glenn Youngkin signed it on Monday.
- * The budget passed 94-6 in the House of Delegates and 39-1 in the Senate, with Sen. John McGuire, R-Goochland, the lone nay vote. He is currently in a competitive primary race against Rep. Bob Good, R-VA05.
- * The deal prevented a potential government shutdown this summer, with lawmakers and Gov. Youngkin at odds over what should be prioritized. Democrats wanted more spending, while Youngkin wanted more tax cuts.
- * In the end, Democrats say they were able to include their priorities while avoiding any tax cuts.
- * Youngkin was unhappy about the lack of tax cuts, but he praised that there were no tax increases.
- * The General Assembly has commissioned a study of the state tax system in

anticipation of a potential overhaul next year.

- * Another win for Youngkin in the new budget is that it does not require Virginia to reenter RGGI.
- * The budget also cut the Virginia Military Survivors & Dependents Education

Program that provided a tuition waiver for spouses and children of military veterans killed or severely injured in the line of duty. The current program allows them to attend public colleges and universities for free. Now, they must first apply for other federal aid options first. The new language also prevents the program from covering graduate programs and limits it to Virginia residents.

* Lawmakers went home Monday, but likely not for good. Instead of adjourning, they recessed, anticipating coming back sometime this summer to discuss skill games legislation.
