Sheriff Kincaid provided an interesting and informative presentation with emphasis on scams affecting all of us on a daily basis. One attendee actually received a scam call during the meeting and Sheriff Kincaid asked to answer. When she asked questions the caller hung up. Another received 3 email scams during the meeting. She suggested having a code word or some code with family members to protect against the "grandson in trouble or accident type calls.



Author Cindy Bennett & "Wicked Fairfax County"

Author Cindy Bennett kept the attention of attendees with tales of "Wicked Fairfax County" starting in the 1800's and going through the capture of 3 Cold War Spies. It included the imprisonment and beating of women suffragists protesting for women's right to vote near Lorton. However, the one drawing the most questions was the nudist camp in Reston area from 1933 to about 1949. It ended after a man murdered his wife and baby on the then isolated property. Several of us purchased her book on this subject.

Congressional primary elections for the 10th and 11th Districts will be held on June 18. Early voting starts on May 3.

Karrie Delaney, one of our scheduled speakers for May, was one of the sponsors for a bill preventing elder abuse, which was signed by the governor. Her bill on prescription drug affordability, which passed the General Assembly by a bipartisan vote, was vetoed by the governor.

New state Senator Russet Perry (D-Loudoun) had several bills passed into law.

The General Assembly will go into special session on May 13 to reconsider the state budget.

WHAT TO KEEP/HOW LONG/WHAT TO TOSS:

Most of us have a lot of paper documents and "kind of know" what we should keep for how long, etc. However, recommendations vary and can change and a reminder is always helpful. It was particularly helpful to me as I (like many of you) am trying to purge. This is taken from Michelle Singletary's column in April 21, 2024 Washington Post Business:

Forever: birth and adoption records, death certificates, marriage and divorce records, social security cards, military service records, loan payoff statements, year-end pay stubs, retirement or pension records, and funeral programs as they often have valuable information such as maiden names, family history, etc.

It Depends: Loan Documents except for final loan pay-off, vehicle title as long as you own vehicle, home improvement records (useful when selling), investment statements.

3-7 Years: Tax Records (IRS will accept scanned copies), Medical Bills (consider tax record)

<u>1 Year:</u> Credit Card Statements – suggests getting e-statements

Less than 1 Year: ATM or retail receipts (still important if you need to return an item)
