Legislative Corner By Ed Weiler

#### Two Helpful Bills Passed in Richmond During the 2024 Session of the General Assembly

Not to dwell in doom and gloom, but the reality is that we are all getting on in years, and thus need to give serious thought to those "what-if" scenarios should they materialize.

Enhancement of Virginia's Advance Health Care - Directives Registry (SB154; HB188)

Created by law more than a decade ago, Virginia's Advance Health Care Directives Registry is a service offered by the Virginia Department of Health (VDH) and ConnectVirginia HIE (vhi.org/connectVirginia/, in partnership with the U.S. Living Wills Registry, to provide individuals an on-line "home" for their Directives, and

other related documents. Among other things, *SB154/HB188* authorizes individuals to post a *Do Not Resuscitate Order (DNR)*, as well as a *portable medical order* (the most commonly-used acronym is POLST).

While most of us are familiar with the DNR, such might not be the case for the POLST, as it was not for me. In a nutshell, a POLST addresses a range of life-sustaining measures, and allows a person to choose **treatment** as well as to **forego treatment**. A key feature of the POLST is portability, in that it accompanies a patient to all treatment settings ... i.e., hospital, nursing home, or personal residence. By contrast, a DNR addresses resuscitation exclusively, and thus only allows for **foregoing treatment**. As a general proposition, the POLST decision-making process is for a seriously-ill patient with a limited projected life span.

To access the Registry, go to: vhi.org/connectVirginia/. For more information on the POLST, go to: <a href="https://www.vdh.virginia.gov">https://www.vdh.virginia.gov</a>, then type "POLST" into the search box. Note that the POLST form must be filled out only by a physician.

Reporting by Financial Institutions of Suspected Financial Exploitation of Elderly or Vulnerable Adults - (SB174/HB692)

We've all heard stories about an elderly person being fleeced by a close relative, or perhaps a caretaker, who cajoles or coerces the withdrawal of significant sums of money from one or more of the victim's financial accounts. Or, perhaps the elderly victim, due to diminishing mental capacity or sheer loneliness takes it upon him/her self to unduly shower others with financial largesse. Why didn't someone blow the proverbial whistle on this before it got out of hand, one might ask?

Enter *SB174/HB692*, which permits a financial institution to allow an individual to designate a trusted person (or a list of such persons) whom the institution might contact in the event of account activity suggestive of financial exploitation. This legislation also directs Virginia's Bureau of Financial Institutions to publish guidelines for the training of financial institution staff to spot suspicious activity.

The concept, and indeed the practice, of establishing a "trusted contact" in the context of financial accounts is by no means new. Most of the larger public-facing financial institutions (e.g., Vanguard, Fidelity, Schwab) implemented this practice several years ago. With SB174/HB692 in place, however, your local bank might soon be offering this service. In the event you missed the point, the service in question is **protecting you from yourself.** 

## **VFN Conference Report**

The 2024 VFN Conference was a productive, jam-packed event with 116 members and guests present, including our National President and Region X Vice-President. After a welcome from the Director of Public Relations for the Hotel Madison Monday morning, we settled down to the business of the day which included officer/committee reports, a video from Senator Tim Kaine who continues to push for GPO/WEP repeal and a merit-based civil service, speakers from the Alzheimer's Association Central and Hearing Associates of Northern VA, election of state officers, workshops and Area caucus meetings. During breaks and lunch, there were opportunities to visit the exhibits and bid on silent auction and other items for Alzheimer's research. Buffet lunches allowed time for members to socialize as did the Welcome Reception Monday evening. National President, Bill Shackelford, was the keynote speaker on Monday. Officers elected for the upcoming year included: President, Frances Boatman, 2nd Vice President, Patricia Wolfe, Secretary, Doris McAdams and Treasurer, Jim Little, all of whom were elected by acclamation since they were unopposed. Since the office of 1st Vice President has two candidates, election for that office will be done by ballot, either electronic or mail so

be on the lookout for your ballot. Ted Pasek was re-elected Area X VP, and I am serving as Area X's representative to next year's Nominating Committee.

Tuesday's session began with program chair introductions, followed by a memorial service for deceased members. Mark Arpa from Vienna-Oakton's chapter provided music while 1st VP Larry McIlvee was soloist. Our chapter memorialized 2 members. After break, the Honorable Ben Cline, Virginia's 6th congressional district, was presented as our keynote speaker. He is a member of the Judiciary, Appropriations and Budget Committees and committed to sign on as co-sponsor for GPO/WEP repeal. Congressional District Leaders for the 118th Congressional Session were introduced by VFN's National Legislation Chair, Gaston Gianni. Following lunch, we received an ECC briefing and presentations from Professors at JMU --one on "Deep Tech for Good: Al for Sustainability and Prosperity" and another on "Cyber Security for Seniors". The evening banquet included installation of VFN officers as well as special presentations.

Wednesday's closing session included remarks by Region X VP, Robert Allen. The VFN has 10,000 members of the total region membership of 18,000. He mentioned a potential bylaws change to make the national Secretary/Treasurer position a non-residential position as well as changes to FedHub and an upcoming strategic plan. Both he and President Shackelford encouraged members to come to FedCon from Aug 18-20. Keynote speaker, Nora MacDonald, Director of NARFE Member Engagement, discussed what her department is doing to enhance membership recruitment and retention. Many thanks to Chapter 7 members for providing items for the Alzheimer's silent auction and for being a "Supporter" of the 2024 Conference. I hope more of you will consider attending in 2025 --busy, but much fun!
