## Legislation Update and News of Note

Change to the Cost-of-Living Calculation (COLA) Formula

On March 21, Sen. Bob Casey (D-PA), Chairman of the U.S. Senate Special Committee on Aging, introduced the Boosting Benefits and Cost-of-Living Adjustments (COLAs) for Seniors Act, 3974. The legislation aims to aid seniors with rising living costs by proposing a significant adjustment in the calculation of COLAs to better reflect the expenses faced by older adults. Sens. Richard Blumenthal (CT), Peter Welch (D-VT), John Fetterman (D-PA), Kirsten Gillibrand (D-NY) and Bernie Sanders (D-VT) co-sponsored the bill. The current COLA formula is based on the Consumer Price Index for Urban Wage Earners (CPI-W). The bill advocates for using the Consumer Price Index for Americans aged 62 or older (CPI-E), which more accurately accounts for seniors' spending patterns, including a greater emphasis on medical expenses.

## Repeal of the WEP and GPO

On April 16, the House Ways and Means Subcommittee on Social Security held a hearing on the Social Security Fairness Act, which would repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), the second hearing this Congress focused on these issues. The hearing featured think tank witnesses rather than representatives from those directly impacted; however, NARFE President William (Bill) Shackelford submitted written testimony for the record which stated in part that: "For over four decades, the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) have unfairly reduced, and even wiped out, the earned Social Security benefits of public servants, punishing those who chose to answer the call to serve their nation, states and local communities. These two 40-year-old provisions of the Social Security Act that were intended to prevent public sector retirees from "double-dipping"

with pension benefits, but instead block them from receiving the full benefits to which they say they are entitled for work outside of public service....WEP and GPO were arbitrary, unfair and punitive when they were enacted, and remain so today." It is unclear what direction the Congress will take. Many lawmakers supported a full repeal of the WEP and GPO, however, others seek to keep the provisions, but reform their calculations.

### Schedule F

On April 4, the Office of Personnel Management (OPM) published new regulations designed to insulate federal workers from a revival of Schedule F. The regulations guarantee employment protections unless a worker voluntarily waives them. It also ensures that any future administration cannot apply broad descriptions of positions, like those of a "confidential" or "policymaking" nature, to career civil servants for the purpose of converting them and sets up an appeals process before the Merit Systems Protection Board for any employee moved out of the competitive service or between schedules in the excepted service. The regulations are set to take effect in May. NARFE President Bill Shackelford issued the following statement: "NARFE applauds OPM's commitment to upholding the merit-based, nonpartisan civil service and welcomes this final rule, which clarifies and reinforces long-standing protections for our public servants....Publication of this rule creates a procedural roadblock in the way of any future administration looking to undermine merit-based protections via a return of Schedule F, or other similar efforts....While OPM's actions are a step in the right direction, a rule alone cannot prevent a return of Schedule F in the future. It's up to Congress to clarify its statutory intent further, by passing legislation such as the Saving the Civil Service Act, H.R.1002/S.59, to more fully protect the nonpartisanship of the civil service."

# Social Security Numbers to Be Removed from Documents Mailed by Federal Agencies

On April 12, the Office of Personnel Management (OPM) issued a final rule that removes Social Security numbers in documents mailed by Federal agencies in an effort to prevent fraud and potential identity theft in partial implementation of the 2017 Social Security Number Fraud Prevention Act. That legislation prohibited federal agencies from using Social Security numbers in any mailed document unless deemed necessary by agency leaders. As such, OPM's final rule amends its privacy procedures to incorporate the law for all records it maintains and "uses to identify, track and correspond with agencies, federal employees, contractors and annuitants, among others." The rule also partially redacts the numbers where feasible and ensures their removal from the outside of any package, envelope, or any envelope window. The rule is scheduled to go into effect on June 26.

## Alzheimer's Corner *Marilyn Markman, RN*

Ever wonder where Alzheimer's came from? Well, here is the story - November 3, 1906, a clinical psychiatrist and neuropathologist named Alois Alzheimer reported "a peculiar severe disease process of the cerebral cortex." He had been following a 50-year-old woman for 5 years noting progressive sleep and memory disturbances, aggression, and confusion. Upon her death he examined her brain and found many abnormal clumps (now called amyloid plaques) and tangled bundles of fiber (now called neurofibrillary, or tau, tangles). These plaques and tangles in the brain are still the main feature of Alzheimer's. In 1910 a psychiatrist, Emil Kraepelin, wrote a text that included "Alzheimer's disease" and that was the beginning of Alzheimer's!

Today most of us are aware of the Alzheimer's Association and a little less well-known Alzheimer's Foundation of America (AFA). Here is some information about these 2 organizations:

Alzheimer's Association - In 1980 Jerome H. Stone and a group of caregivers recognized the need for an organization that would unite caregivers, provide support to those facing Alzheimer's, and advance research into the disease -Alzheimer's Association was born. Now a leading nonprofit voluntary health organization in Alzheimer's care, support and research, it has a 78-chapter network across America with a charity score of 96% - 4 star rating. In fiscal year 2023, total revenue equaled more than 432 million dollars. The first well-known Alzheimer's walk was August 19, 1995. In 2000, the walk moved from August to November to tie in with other activities during National Alzheimer's Awareness month.

The association has stopped publishing the magazine "ALZ", however it can be accessed online at their website by <u>using this link</u>. Our local chapter is:

Alzheimer's Foundation of America (AFA) - In 2001 AFA was founded by Bert Brodsky whose mother lived with Alzheimer's from 1980-1992. His goal was to make sure that no other family living with Alzheimer's disease would have to follow the journey alone. AFA is dedicated to meeting the educational, social, and emotional needs

of individuals and families affected by Alzheimer's. This nonprofit, based in New York City, unites more than 2,000 members coast-to-coast and has a 96% charity score - 4 star. They can be reached at:



## **Previous Chapter Meeting, April 17th**

Chapter 356 held its regular monthly meeting, with eleven members and three guests present. The guest speaker, Jim Lewis, a local Civil War Historian, presented a historical forensic story about the skeletal remains of six Civil War soldiers discovered by a local relic hunter in what was to become a McDonald's in Centreville, VA. He described the ensuing excavation, exhumation, and research led by archeologists and forensic anthropologists from Fairfax County and the Smithsonian Institution that led to their identification and subsequent internment with full military honors in Massachusetts, their home state. The historic marker below, authored by Mr. Lewis, was installed at the site and recounts the local story he presented at our meeting



Additional information may be found online in the local newspaper CentreView, May 22-28, 2019, pp.3 and 6 titled "Bringing Closure to a Civil War Mystery in Centreville" (centre-view.com.

A short business meeting was conducted after the presentation, with officer and committee reports. The Minutes of the February 21, 2024, chapter meeting, as reported in the March Newsletter, were approved, and the Treasurer's Report was adopted. The House Committee on Ways and Means Subcommittee on Social Security held a hearing on April 16 on repeal of the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO).

The raffle for the Alzheimer's Fund collected \$26, with the winner donating her share.

The Northern Virginia Caucus meeting will be held on Friday, April 26, 2024, at the American Legion in Fairfax.
