PRESIDENT'S MESSAGE - KATHY ARPA


So many people have been affected by Hurricane Helene and we are keeping them in our thoughts and prayers.

REPORT OF SEPTEMBER 10TH CHAPTER MEETING – DAVE GRAF

President Kathy Arpa called the Chapter Meeting to order at 1:07 PM on September 10, 2024, at the Vienna Community Center (VCC). Kathy welcomed back chapter member Doug Smith and recognized several guests. Following the Pledge of Allegiance, there was a Moment of Silence for September 11th.



Kay Dellinger introduced the guest speaker, Jennifer Gittins-Harfst (pictured on the left). After a lengthy career in the technology field, she earned the Professional Organizer Certification and two years ago founded her company, No Frills Organizing, LLC. Her presentation was entitled "Organizing for Seniors" and was focused on how to bring order to your home and included tips for getting organized and for maintaining order. Jennifer also provided extensive lists for disposing of various items. The presentation ended with a Q&A session. [A summary of her presentation immediately follows this report.]

Following the presentation, Happy Birthday was sung for everyone who had a birthday during the summer and in September. This was followed by a break during which members enjoyed an array of goodies provided by Hostess Jayne Seidman.

The business meeting was convened at 2:44 PM. Dave Graf read the Secretary's Report from the last membership meeting on May 14th and gave the Treasurer's Report, including a summary of the receipts and expenses for the Chapter's 55th Anniversary Celebration that was held on June 11, 2024. Membership Chair Jayne Seidman reported that the Chapter has 159 members.

The State Legislation report was presented by Chris Gieseler. He stated that the state legislators have begun to "prefile" legislation for next January's Regular Session of the Virginia General Assembly. Chris also gave an update on the drafting of the 2025 Virginia Federation of NARFE (VFN) Legislative Plan.

The National Legislation Report was presented by Jim Hathaway. His report focused on the progress toward getting a floor vote in each house of Congress to eliminate the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) laws that reduce the Social Security benefits for certain retirees. Jim also reported on actions by the Office of Personnel Management (OPM) and Congress regarding the future of remote work for Feds.

Programs Chair Ralph Dantinne announced the upcoming Chapter meetings and a special Northern Virginia NARFE event to be held the end of the week in our VCC meeting room. The meeting was for current and prospective NARFE members.

Kathy presented Margaret Murphy (pictured here) with a Certificate of Appreciation for her support of the Chapter at our monthly meetings. The certificate was signed by VFN President Frances Boatman.

Some Tips from the "Organizing for Seniors" Presentation by Jennifer Gittins-Harfst Professional Organizer – www.NoFrillsOrganizing.com

What is Organizing? • Having an orderly home: — Clean and free of random piles — Items in boxes/bins are known and labeled — Stored items are visible • Having orderly records: — Centralized listing of all household/personal accounts — All paperwork/records are organized, and updated regularly • Organizing can be an emotional process: — Parting with possessions can trigger anxiety, frustration, anger, or depression — Acknowledge the emotions, work through them, and the results will be worth it!

Can You Get to 10? • How long would it take you right now to find the following 10 items? – Birth certificate – Tax return from three years ago – Car title – Marriage license – Social security card – Will (and other end-of-life legal documents) – Spare car key – Spare house key – Passport – Mortgage pay-off documentation.

Senior-Specific Suggestions • Clear clutter from steps/entry; mount "holding" basket to the wall. • Do not store items too high (risk of falls) or too low (difficulty bending over). • Get rid of broken/unused items that could be dangerous - mugs/glasses, electronics/wires, appliances, chairs/couches, old medications. • Keep valuables out of sight when home repair contractors come over. • "If you haven't by now, you probably never will" (those 'someday' projects) • Do I need it? Do I have something similar? Can I afford it? What emotions am I feeling when I make the purchase? • To help minimize accumulation of 'stuff', encourage friends and loved ones to buy you non-tangible gifts, for example: • Tickets to theater, sporting events, movies • Registration fees for rec/senior center, classes at OLLI/LLI • Professional services for cooking, cleaning, transportation, errands, organizing • Car care, such as oil change, car wash, car maintenance • Flowers or plants • Self-care experiences such as beauty salon or spa • Gift cards for restaurants, drug store, coffee house, department/big box store • Treats, such as specialty teas/coffee, gourmet gift basket, unique wine/beer, subscription to fruit/cheese/cookie-of-the-month, and Edible Arrangements.

LEGISLATION REPORTS

NATIONAL LEGISLATION REPORT-JIM HATHAWAY

2025 Health, Dental, and Vision Insurance Premiums

The Office of Personnel Management (OPM) has released the 2025 premiums for the Federal Employee Health Benefits Program (FEHB) and the Federal Employees Dental and Vision Insurance Program (FEDVIP).

For 2025, the average increase in premiums for current <u>non-postal</u> federal employees and retirees ("employee share") will be 13.5%. The increase was 7.7% in 2024 and 8.7% in 2023.

Overall, the average increase for the total 2025 FEHB premiums will be 11.2%, compared to 5.8% in 2024 and 7.2% in 2023. The Federal Government still covers approximately 70% of the total cost, making it a valuable benefit for federal employees and retirees.

Per OPM, the cause of these premium hikes is mainly due to price increases by providers and suppliers, higher utilization of certain prescription drugs, and more spending on behavioral health. OPM also stated that these increases are similar to those in the commercial market. The historical average FEHB premium increases works out to 5.2 percent per year since 2009.

A to-do list for the Federal Benefits Open Season

- Mark your calendar: Open Season runs from November 11 to December 9, 2024.
- Review your options: Check out your FEHB and FEDVIP plan options.
- Attend the Congressman Gerry Connolly (VA-11) 15th Annual Open Season Workshop for Federal Employees and Retirees at the Fairfax County Government Center, on November 16.
- Make changes: Decide if you need to make any changes to your current plans.
- Enroll: Sign up for the plans you want for the benefit year starting January 1, 2025.

Status of the 2025 COLA and 2025 Federal Pay Raise

For current federal employees, it looks like you are in for an average pay raise of about 2% in 2025. This figure became likely when the President issued his alternative pay plan letter for the 2025 raise. However, it will not be set in stone until he finalizes it with an executive order, which usually happens in December.

For federal retirees, the 2025 COLA has not yet been announced. We will know more in mid-October when the latest inflation data comes out. The August 2024 inflation report suggests that the COLA could be around 2.6%.

It is important to remember that the annual federal pay raise and the COLA are different. The COLA is for federal retirees, while the pay raise is for current federal employees. They are calculated differently, which can be somewhat confusing.

Status of Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) in Congress

There has been a lot of speculation lately about the potential repeal of the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) in Congress. Here are the latest updates:

- 1. The Social Security Fairness Act, which aims to repeal both WEP and GPO, has achieved a major milestone. It reached the 218-signature threshold needed to force a floor vote through a discharge petition. This means the bill is closer than ever to being voted on in the House. However, due to procedural rules and other legislative priorities, the vote probably will not happen until at least November.
- 2. Over in the Senate, the companion bill has gained support from 62 bipartisan cosponsors but has not yet moved towards a floor vote. Advocates are now focusing on pushing the Senate to take action.
- 3. The Congressional Budget Office (CBO) estimates that repealing WEP and GPO would cost approximately \$196 billion over ten years. This hefty price tag could complicate the bill's implementation, as it would increase the cost of the Social Security trust funds by approximately six months.

These provisions have long affected the retirement benefits of nearly three million public servants, including federal retirees, as well as state and local employees.



Election Day, November 5

Election Day is approaching for 2024. Virginia voters are beginning to cast their ballots in a contentious presidential election year, with several competitive congressional races on the ballot. There are Virginia election guidelines that must be followed for your vote to count. These are subject to change periodically. The current guidelines and important dates can be found in an easy-to-read form on https://www.elections.virginia.gov/voter-pocket-guide. Successful elections are important and are dependent on your vote. Some

of our members have voted early and avoided the potential long lines.

VIRGINIA STATE LEGISLATION REPORT - CHRIS GIESELER

VFN Virginia 2025 State Legislative Plan

According to State Legislative Chair Deborah Brown of the Virginia Federation of NARFE (VFN), the VFN's Virginia 2025 State Legislative Plan (the Plan) is being printed in its customary "trifold" form and will be presented at the October 2024 meeting of the VFN Board of Directors. The Plan lists four legislative priorities that VFN would like the Virginia General Assembly to enact during the legislature's January 2025 Regular Session. There issues include:

- 1. Retain the current standard deduction for the Virginia state income tax;
- 2. Expand the age-based, state income deduction (the Age 65+ Deduction);

- 3. Exempt from state income tax a portion of CSRS pensions, in an amount equivalent to Social Security benefits; and
- 4. Address several nursing home issues (e.g., nursing home staffing levels, and pay & benefits of nursing home staff).

I had the privilege of collaborating with the Legislative Team that put the Plan together. As discussed elsewhere in this Newsletter, Ms. Brown is scheduled to be the speaker at our Chapter's October 15, 2024 Chapter meeting.

REPORT OF NORTHERN VIRGINIA NARFE EVENT – SATURDAY, SEPTEMBER 14, 2024
