October Program Report -- At the Chapter's October meeting, Roy Wagner, a member and past president of the local Apple Technology Group, gave a presentation on the practical

applications of technology in daily life. Although his experience is specifically with Apple devices, the uses of technology span all brands. He shared his personal journey through various Apple devices, from the first iPhone and iPod to the latest models, and how they have evolved over time. He also discussed his morning routine, which starts with waking up to a programmed, gradually brightening indoor light, simulating the sun's rise. Mr. Wagner then shared how he uses his Apple devices to stay active and informed throughout the day, explaining how they have evolved and replaced the non-technological items in our lives. He invited his audience to consider how their lives today compare to their pre-tech routines. Among the more common applications (and what they

replaced) are: books on Kindle (hard copies in homes and libraries); texts and cell phone voice mail (landline phone recordings); alarms and reminders for upcoming activities (paper calendars and notes); cell phone camera with

cloud storage (individual camera with printed pictures); traveling directions via Global Positioning System (paper maps); Zoom (in-person meeting); on-line games played across many geographical locations (board and card games played in-person); credit card phone or watch app to pay in store (plastic credit card); and banking on-line (in-person at a bank). Many people use the Apple watch to monitor their health in terms of physical activity, cardio well-being, and attaining personal goals. He recommended the book 100 Things We've Lost to the Internet to gain additional insight on this topic. He concluded the presentation answering specific trouble-shooting questions, which was greatly appreciated by attendees. <u>LEGISLATION REPORT</u> – H.R. 82 Social Security Fairness Act – This bill, which would



repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), now has 329 co-sponsors and 218 members signed the Discharge Petition to permit a vote when Congress returns from recess on November 12th. Now the focus is on the Senate Companion Bill SB 597 which has bi-partisan support. Unless there is a way to circumvent the Discharge Petition, we should finally have

a recorded vote on H.R. 82. Let's hope all 218 of those who signed the Discharge Petition and most of those remaining from the 329 co-sponsors say "Yes" when the vote comes.

2025 Federal Budget -The Government Shutdown was averted this month. When Congress returns on November 12th, they have about 5 weeks to get the Federal Budget Resolved or push for yet another Continuing Resolution (which could be the case depending on the election results).

State Legislation -- The Virginia Federation of NARFE's (VFN's) 2025 State Legislative Plan should be posted very soon. I have a few advance copies which I will bring to the next chapter meeting.

Don't forget to vote! This will be the closest of elections since probably 1960. Not only are you voting for the next President, but all House seats are up for election and Virginia has one Senate seat up for election. **Mary Ann Munley, Legislation Chair**
