#### **REPORT OF OCTOBER 15<sup>TH</sup> CHAPTER MEETING – NANCY BURKE-SANOW**

President Kathy Arpa called the Chapter Meeting to order at 1:00 PM on October 15, 2024 at the Vienna Community Center (VCC). Kathy recognized several guests including Pat Meyers and Nancy Palmerino from Chapter 7 (Arlington), Mary Ann Munley from Chapter 1159 (Annandale) and Carol Campbell, Area IX Vice President from Chapter 356 (Manassas). Following the Pledge of Allegiance, led by Judy Hathaway, there was a Moment of Silence for families and friends affected by Hurricanes Helene and Milton.

Chapter State Legislation Chair Chris Gieseler introduced the guest speaker, Deborah Brown, VFN Legislative Chair. Deborah explained the rationale behind the four legislative issues in the VFN Virginia 2025 State Legislative Plan. They

are (1) Repeal of Sunset Provision for Virginia's Current Standard Deduction Amounts, (2) Revisions to the Age 65+ Deduction, (3) Exempting a Portion of CSRS Pensions Equivalent to Social Security Retirement, and (4) Nursing Home Priorities. Deborah also shared information on the make-up of the VFN Board and highlighted some of the activities she has participated in around Virginia. Mary Ann Munley and Chris Gieseler (from our Chapter) who helped draft the 2025 Legislative Plan, clarified their contributions to portions of the plan. #### NATIONAL LEGISLATION REPORT-JIM HATHAWAY

#### **Congress Returns Home to Campaign**

Members of Congress left Capitol Hill to hit the campaign trail for the six weeks leading up to Election Day, leaving a lot of their work unfinished. The Republican-led House and Democratic-led Senate are on recess until November 12.

Now that the election is over, lawmakers will return to Washington, D.C., where they will need to tackle the must-pass legislation they have put on hold instead of negotiating new bipartisan compromises. So far this year, they have delayed reaching agreements on crucial measures like the farm bill, this year's government funding bills, and the annual defense policy legislation.

#### Federal Employee Return to Work Act

There's a new bill in the House about teleworkers and their locality pay. Rep. Dan Newhouse from Washington has introduced the Federal Employee Return to Work Act (H.R. 10014). This bill says that if federal employees telework at least once a week, they won't get the locality pay based on their official workstation. Instead, they'll be considered part of the "Rest of U.S." locality pay area, which could mean a pay cut of up to 30%.

This House bill is a companion to a similar Senate bill introduced by Sen. Bill Cassidy from Louisiana back in August. Locality pay, especially in cities like New York, San Francisco, Houston or Washington, D.C., make up a significant portion of a federal worker's salary—up to 30%! The idea behind locality pay is to reduce pay gaps between federal and private sector workers within a region, making it easier for agencies to attract talent. There are some exceptions, though. The bill doesn't apply to federal employees with disabilities, members of federal law enforcement, the Foreign Service, or active-duty military. But it does affect the 85% of the federal workforce whose homes and official worksites are outside the D.C. area. Interestingly, Newhouse hasn't introduced a companion bill for Cassidy's other telework proposal, which would change how locality pay factors into retirement calculations for new federal employees.

#### VIRGINIA STATE LEGISLATION REPORT – CHRIS GIESELER

The Virginia Federation of NARFE's (VFN) Legislative Team met via Zoom on October 18, 2024. The meeting was called to order by State Legislative Chair Deborah Brown, who stated that the purpose of the meeting was to gather information regarding ways for the VFN to get word to Virginia state legislators regarding the VFN's 2025 Virginia State Legislative Plan. She reiterated that the VFN Board had formally approved the Plan earlier in October. (Copies were distributed at our October Chapter Meeting.) During the Zoom call, we discussed various strategies for contacting members of the General Assembly about the Plan, including having the Board

communicate with appropriate committees of the General Assembly about the Trail, including communicate with appropriate committees of the General Assembly regarding items on the Legislative Plan that were relevant. Ms. Deborah Fisk, VFN First Vice President and a member of the Legislative Team explained during the Zoom session that, consistent with past practice, the Executive Committee of VFN Board will be sending letters to all members of the General Assembly enclosing copies of the "trifold" version of the Legislative Plan. Ms. Brown said she would keep in mind the protocols of the Board and would make it her responsibility to develop a strategy regarding distribution of the 2025 Legislative Plan.

A limited number of copies of the VFN Board-approved 2025 Legislative Plan will be available at our November 12 Chapter Meeting.
