# **LEGISLATION**

#### Federal

The Social Security Fairness Act of 2023. The Social Security Fairness Act, <u>H.R.82/S.597</u> would fully repeal the WEP and GPO. H.R.82 has 330 co-sponsors. S.597 has 62 co-sponsors including both Virginia Senators.

The Social Security Fairness Act reached the required 218signature threshold needed to force a floor vote through a discharge petition. House Majority Leader Steve Scalise has stated he will schedule a vote on the full house floor after the election. If it passes in the House it will go to the Senate. NARFE President Bill Shackelford sent a <u>letter</u> to Senate leaders in October asking them to bring S.597 to a vote in that chamber.

#### State

Ruth Greene distributed the 2025 VFN State Legislation Plan brochure to attendees. Now is the time to contact your state legislators to introduce bills that address VFN issues and/or support any bills introduced by others.

#### **NOVEMBER 2024 MEETING MINUTES**

The meeting was called to order at 12:10 p.m. with 27 people in attendance including our guest speaker. There were two new members and two guests. A quorum was present to conduct chapter business.

November birthdays were recognized.

Veterans were recognized and received a round of applause.

Wanda Ware, Chaplain, discussed the history and meaning of Thanksgiving Day and led us in prayer and the Pledge of Allegiance. She asked that we send get well wishes to Elaine Drewry who is recovering from a leg injury.

The Secretary's minutes for the October 2024 meeting were approved as published by acclamation.

Ellie Long, Secretary, reported one member death.

Ellie gave the October 2024 treasurer's report.

Carolyn Tucker gave the membership report. Currently there are 149 chapter members. She and other chapter members participated in three well attended membership drives in October. Welcome to new members **David Cundiff, Bob Fetzer, Ben Trunzo, Linda Watson, and Lawrence Williams.** 

Karen Simmons said a comprehensive search for a new meeting place was conducted and asked if Olive Garden would be acceptable for our new permanent meeting location. Those in attendance approved. She discussed meal arrangements and costs for the Holiday Luncheon. Ellie made a motion we pay \$25 per person and Wanda seconded. Motion approved.

Bill Ketron gave the Legislation report.

Ruth Greene, Area VII VP, discussed the 2025 VFN Conference April 6-9 in Harrisonburg. If you're interested in volunteering to help, let Ruth or Frances know.

Frances gave the President's report.

Frances conducted the election for our 2025 officers. There were no nominations from the floor. With no other candidates, Frances Boatman, Carolyn Tucker, Karen Simmons, Ellie Long, and Mark Fisher were re-elected. Motion made by Frances, seconded by Don Conner. Motion approved.

BC/BS Basic Option, Standard Option, Blue Focus, Dental, and Vision all have rate increases in 2025. The \$800 Medicare Reimbursement remains in Basic option.

Nothing on the plans changed if you have Medicare A & B. Added was a weight loss program; you receive a scale and one on one coaching.

The Postal Service Health Benefits (PSHB) Program is a health benefits program exclusively for USPS employees, retirees and their families. One of the PSHB requirements is that you must join your health plan's Medicare Part D prescription drug plan.

-You do not have to enroll in Medicare Part B but if you have it, depending on your income level, you may need to pay an Income-Related Monthly Adjustment Amount (<u>IRMMA</u>) for this Part B coverage

-You have to take the Medicare Part D prescription drug plan. You can opt out, <u>but you will have no prescription</u> <u>benefit coverage</u>. So don't do it. This is true for all PSHB plans, not just the one for BC/BS.

-Medicare Part D is not a separate plan; it's automatically included. You do not have to buy anything else. It replaces the prescription drug plan you had under your previous insurance. Depending on your income level, you may need to pay an IRMMA for this Part D coverage and you cannot use coupons with this program.

-You will automatically be enrolled. The code will change and premium will increase a bit more than non-postal plans. Confirm your enrollment with your plan representative.

There was a brief discussion about switching from BC/BS Standard to Basic. The concern was Basic does not pay for out of network charges. (Locally, Lewis Gale ER physicians aren't in network, but Medicare covers them.) Morgan said in general, it was rare that out of network claims under Basic were declined and were always approved for life and death emergencies.

The 50/50 (Alzheimer's Fund) drawing was won by Bill Ketron.

The meeting was adjourned at 2:03 p.m.
