NATIONAL LEGISLATION REPORT

FY2025 appropriations status: The current Continuing Resolution (CR) is still in effect until Dec 20, 2024. There hasn't been any news regarding an extension or action by Congress on the FY2025 appropriation bills. Stay tuned as things should heat up quickly.

An item that we have been tracking is really in play now; H.R. 82 the Social Security Fairness Act to repeal the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO), passed the House on Nov 12th with overwhelming bipartisan support, 327-75. Although S.597, the Senate version of the Socia Security Fairness Act has 60 co-sponsors which is enough to be brought to the floor for a vote also giving it a filibuster-proof majority. We are now urging the Senate to bring this bill to the floor. Since this is the furthest these bills have gotten, it makes sense to continue the momentum before the session ends this month. Please use the NARFE Action

Center to urge your senators to make that happen. The issue is that this is the last month of the current Congress; if S. 597 does not get to a floor vote, everything that has been done so far will have to be restarted in the next Congress.

There is currently a rally going on at the U.S. Capitol jointly hosted by NARFE, the International Association of Firefighters (IAFF), the Fraternal Order of Police (FOP), the National Education Association (NEA), the American Federation of Teachers (AFT), the American Federation of State, County and Municipal Employees (AFSCME), the American Federation of Labor and Congress of Industrial Organization (AFL-CIO), and more – to urge Senators to vote on and pass the Social Security Fairness Act. We'll also be joined by leaders of the effort in the Senate and House. Hopefully that will get some action in the Senate.

Consider going to the advocacy page of the NARFE.org website where there are prepared letters on some of the topics discussed above or that are important to federal employees/retirees. You can write your own letter/e-mail and they will ensure that it is sent to your representative and senators plus notify you that the e-mail was sent. NARFE also gives you the ability to send comments to your representative and senator using Twitter ("X") if that is your preference.
