Legislative Corner Ed Weiler

Call for All chapter 7 Members to Advocate for Passage of Virginia's Senate Bill 108 (that would protect the current enhanced standard deduction levels in Virginia's State Income Tax)

Back in October, the *Legislative Corner* covered the Virginia's Federation of NARFE Chapters (VFN's) 2025 State Legislative Plan (now available @ VANARFE.org). The first item on this list calls for the passage in 2025 of a bill (SB108) that was considered in 2024 by the Senate's Finance and Appropriations Committee, and recommended unanimously for carryover to the following session of the General Assembly.

Here's what you need to know. Under current law, recently-enhanced standard deduction levels for Virginia's State Income Tax (\$8.500 single; \$17,000 married, filing jointly) will revert to levels that prevailed in 2005 (\$3,000 single; \$6,000 married, filing jointly). In terms of 2024 dollars, that \$6,000 deduction will be worth only approximately \$3,714. *SB108* would repeal this "sunset" provision in current law, and provide for the current enhanced levels for 2026 and beyond.

Fortuitously, most of Chapter 7's members reside within the District boundaries of either Sen. Favola, or Sen. Ebbin (District 40 or District 39, respectively), both of whom sit on Finance and Appropriations, and voted in 2024 to have *SB108* carried over to 2025. Got it? For this plank in VFN's State Plan, we don't have to go shopping for a sponsor to submit a bill, since *SB108* is already in the hopper, and key Senators have already committed to give it a hearing in 2025. In baseball terms, *SB108* is already perched on first.

What you are asked to do is email your Senator and urge a positive vote on *SB108*, first in committee, and then again, if and when it comes up for a floor vote.
