<u>February Program Report</u> – Our speaker was <u>Detective Sergeant Amanda</u> <u>Paris</u> of the Fairfax County Police (FCP) Threat Assessment and Management

(TAM) Unit. We received an excellent presentation regarding the goals and operations of the TAM in assessing and managing potential threats to citizens of Fairfax County as well as other local jurisdictions. She discussed the importance of recognizing and addressing potential threats to prevent mass violence. She shared a case study of a potential shooter who was stopped due to a community member's report concerning social media posts. Amanda emphasized the importance of taking all threats

seriously, even if they seem like jokes, as they can escalate into violence. She also highlighted the role of the Threat Assessment and Management Unit in mitigating threats and deescalating individuals on the pathway to targeted violence. The unit collaborates with various organizations and agencies (local, state, and federal) in a "Fusion" environment to provide support and services to individuals and their families. The presentation included two video clips to highlight the seriousness of threats that might sound ridiculous or outlandish as well as the consequences of ignoring the signs of upcoming violent attacks. Sergeant Paris discussed the role of her unit in preventing targeted violence and the importance of community involvement. She addressed questions about interactions with the fire department, the process for handling juvenile threats, and the handling of social media threats. She also discussed the role of her unit in directing individuals who make threats to prevent future issues. She also addressed questions about the handling of false reports (for which there are legal consequences), the use of wellness checks, and the frequency of such checks. She concluded by emphasizing the importance of community involvement and the need for a multidisciplinary approach to address the issue of targeted violence.

Alzheimer's Report — NARFE entered its partnership with the Alzheimer's Association in 1985 and since then NARFE members have contributed over \$16 million for Alzheimer's research. Each year the NARFE Alzheimer's National Committee determines which research projects will be awarded grants from the NARFE Alzheimer's Research Fund. To date the Fund has granted 95 research grants. All donations we collect from Chapter 1159 members go directly to Alzheimer's research. The Chapter Board has established \$4,000 as our donation goal for 2025 and, so far this year, chapter members have donated \$1,403 to the Fund. <u>Legislation Report</u> -- This is the most difficult Newsletter Item I have had to write, bear with me please:

"FORK in the Road" – The email to supposedly offer a buyout deal to Federal Employees is being challenged. Active employees considering the offer should be as informed as possible, and possibly consult with their employment attorney and financial advisors. Terminated Federal Employees impacted by termination without cause should stay informed on legal remedies available to them. NARFE has resources and webinars, and other employee associations and unions have information to consider as next steps. Remaining Federal Employees should continue to do your jobs for the American people as you always do.

Personally, my prayers are with you all that this will all get settled quickly.

The Federal Government has several monumental issues:



FY 2025 Federal Budget: On March 14th, the Continuing Resolution (CR) currently providing FY 2025 funds or operation of the government expires. Congress must act to either extend the CR for a third time, or, make the decision to shut the Federal Government


down. While no one wants to see a shutdown, it may well have to happen. Also be aware, when discussions on Budget Reconciliation occur, "riders" can slip into the Reconciliation agreement which can impact your earned benefits – so please stay informed and respond to NARFE calls to action. Congress is divided. We should all be prepared for the implications of a shutdown – plan for the worst but hope for the best.

Federal Debt Ceiling: Congress must make a decision on whether to raise the Debt Ceiling and if so by how much, or eliminate the Debt Ceiling altogether as the current Administration is demanding. Congress is divided on the issue.

Federal Tax Law 2026: Current federal tax law sunsets at the close of 2025. Absent Congressional legislation, many provisions in the TCJA current tax law will expire (sunset) on December 31, 2025. This "sunset" (continued on page 5)

(continued from page 4) means the tax code will revert to its pre-2017 state, bringing back old rules and higher rates for many taxpayers. Congress is divided. *Good News, HR 82, Social Security Fairness Act* was signed into law in December 2024. Many who had their Social Security entitlements negatively impacted by the WEP/GPO are now filing and receiving their Spousal and/or Survivor Benefits which were previously denied. Those who were "WEPped" are awaiting information from Social Security as to when their 2024 SS benefits and current year adjustments will be made.

Virginia General Assembly: The General Assembly is still in Session, and is also



HB 2575: This bill did not move forward. If enacted, it contained a possible State "subtraction" from VA taxable Income of 20% of a

CSRS Annuity.

Understandably, the State and General Assembly are evaluating the possible impacts of the Federal Cuts on Virginia, especially impact to collection of reduced income tax from federal employees and federal contractors, reductions in federal funding for State education and healthcare, etc. There are a lot of unknowns at this time.
