Membership Report

Current Chapter Members Breakdown: 1-Year 144; 2-Year 24; 3-Year 59; Dues Withholding 60 Life Members 6 The M112 report (which gives us a breakdown of the list of new members, those reinstated, those dropped for non-payment, prospective members identified by National, and other changes) is still not a complete report. The report indicates that there are two pages to the report, but will only display the first page.

VFN President/Membership Chair Frances Boatman recently shared that Virginia had 4,240 chapter members and 6,341 national members for a total of 10,581 and that membership was going in the right direction. At the national level, NARFE has gained many new members (2,300+) since the passage of GPO/WEP and since January 2025 and it continues to go up daily. NARFE HQ is also still processing new applications and renewals that resulted from the extended AMS system outage.

LEGISLATIVE NEWS

While not much legislating is going on, the new administration has been busy reinventing government, and thousands of federal workers who thought they had secure jobs now find themselves out on the streets. Congressmen Connolly and Subramanyam and Senators Warner and Kaine have had heavily attended Town hall Meetings, have attended demonstrations supporting federal workers, have been overwhelmed in efforts to provide quality constituent services, and are awaiting the results of court cases filed against the new administration for perceived unlawful acts.

As of this writing, we are waiting for a government shutdown in two weeks, with the majority party of the House and the Senate still not in agreement as to the expansiveness of the budget bill. Another cliffhanger!

Our legislators have helpful and generally up to date websites. NARFE-PAC is in action. While federal retirees have not taken the brunt of the punishment so far, it is not unlikely that the new administration is eyeing cuts in the funding of medical coverage and other similar measures. March is NARFE-PAC Month. Now is the time to contribute to NARFE-PAC to protect our earned benefits.

Senator Perry provided a brief update on the General Assembly legislative actions. The session had just ended on February 22. She expects that they will be called back. State Legislative Chair Deborah Brown subsequently stated that the date has been tentatively set for April 22. Senator Perry also provided interesting and important information on Data Centers as had been requested. She reported there are 70+ in Loudoun County, 20+ in Fairfax County and 20+ in Prince William County and discussed their impact on the areas in Northern Virginia.* Senator Perry, a former federal employee with CIA, expressed her concern for federal employees everywhere and especially those in her district. Her presentation to our chapter is listed in the March 4 issue of NARFE Newsline that goes out to all NARFE members.

• One concern was the amount of power needed for the data centers and generally provided by Dominion Energy. A question was asked about NOVEC. In the March 2025 Cooperative Living Magazine published by NOVEC, it was stated "NOVEC takes service from the Dominion Energy transmission system which includes 230kV and 500kV high-voltage lines across the state. While Dominion Energy owns ad maintains these transmission assets, the interstate transmission system is operated by PJM Interconnection, located in Valley Forge, Pennslyvania."

SMALL BITES, BIG BENEFITS: The following "uncommon nutrition tweaks for better health" are excerpts from March 2025 Co-Operative Living Magazine:

- Adding more spices/herbs to your meals can help reduce inflammation, protect against cancer and improve insulin resistance. Oregano, cinnamon and turmeric were noted.
- Consider eating your main meal at lunchtime.
- Add more beans to your diet great source of protein.
- Take magnesium supplement to help heart health, strengthen bones, and give more energy.
