NATIONAL LEGISLATION

The United States Senate and House approved identical Budget resolutions that outline measures that may affect Federal employee benefits. A key proposal would reduce the government share of Federal Employee Health Benefits premiums from the current 72 percent to 50 percent over a ten year period by implementing a "voucher" flat payment approach. This would increase premium payments for employees. News reports indicate that this voucher amount would increase at a lower rate than the increase in medical costs. Congress will have to enact specific legislation to implement this proposal.
