NATIONAL LEGISLATION REPORT

FY2025 appropriations status:

We will be under a Continuing Resolution for the full year; H.R.1968 - Full-Year Continuing Appropriations and Extensions Act, 2025 was passed by congress and signed by the President to avert a government shutdown on March 14th. Although the bill was mainly supported by republicans, some democrats voted to pass the bill in order to avoid a government shutdown rather than hold out for the budget to include certain democratic priorities.

For those affected by the Social Security Fairness Act that repealed the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) became law January 5, 2025. From what I've been reading folks that have been receiving reduced benefits started getting their increased payments and retroactive payments starting the end of February. For those that have to apply for social security, as I did since the GPO denied me survival benefits; I urge you to call SSA 1-800-772-1213 Monday through Friday, from 9 a.m. to 6 p.m. ET. I did, they made it easy, provided information set up a phone meeting to go through the application and send in some documents like my marriage certificate and my spouses death certificate.

Note: SSA also announced a new way to apply for retirement, spouse's or surviving spouse's benefits if you did not previously apply because of the WEP and GPO. According to their website, the SSA will take an application by telephone for people who did not previously apply for retirement benefits because of WEP or GPO. If you meet these conditions, call 1-800-772-1213. When the system asks, 'How can I help you today?' say 'Fairness Act.' Then, you'll be asked a few questions. Your answers will help to connect you to a WEP/GPO representative who will help you and get a phone interview scheduled.

The Legislative Action Canter within the NARFE website has letters that they will e-mail to your congressional representative and senators for you. All you need to do is select the letter. Fill in your particulars so that they can align your letter with your representative and the Virginia senators, and they will send it. You can even personalize the letter. The website is
