## **LEGISLATION**

#### **Federal**

These bills are the only ones currently listed on the NARFE Bill Tracker.

The Equal COLA Act, H.R.491, would amend title 5, United States Code, to achieve parity between the cost-of-living adjustment with respect to an annuity under the Federal Employees Retirement System and an annuity under the Civil Service Retirement System, and for other purposes. Referred to the House Committee on Oversight and Government Reform; 47 cosponsors.

Saving the Civil Service Act, H.R.492, would prohibit the establishment of schedule F of the excepted service, and for other purposes. Referred to the House Committee on Oversight and Government Reform; 73 cosponsors.

The FAIR Act, H.R.493/S.126 would increase the rates of pay under the statutory pay systems and for prevailing rate employees by 4.3 percent, and for other purposes. H.R.493 referred to the House Committee on Oversight and Government Reform; 28 cosponsors. S.126 referred to the Senate Committee on Homeland Security and Governmental Affairs; 21 cosponsors including Senator Tim Kaine.

The House of Representatives passed a Republican budget resolution, H.Con.Res.14, on February 25 along party lines, 217-215, that sets the stage for budget reconciliation to enact \$4.5 trillion in tax cuts, and \$2 trillion in spending cuts, including \$50 billion aimed at earned federal retirement and health benefits. NARFE opposed the budget resolution due to its instruction to the House Committee on Oversight and Government Reform to cut at least \$50 billion in mandatory spending under its jurisdiction. Given the only major mandatory spending under the committee's jurisdiction is federal retirement and health benefits, cuts of such a magnitude would necessarily come from cuts to federal retirement and health benefits.

Specific proposals that could be enacted pursuant to the budget resolution include the following:

- Shifting substantial heath care costs onto enrollees, by changing the FEHB program's premium share model to a voucher system where the government would pay a flat amount that would not increase at the same rate as premiums.
- Requiring all FERS employees to contribute 4.4% of their salary towards retirement with no additional benefit, a substantial increase from the current 0.8% contribution for pre-2013 hires.
- Ending annuity supplement payments for FERS retirees who retire before age 62.
- Basing annuities of future retirees on a High- 5 instead of the current High-3.

The President issued an executive order ending collective bargaining with federal unions based on national security reasons. Here is NARFE's <u>response</u> to that action. An executive order issued by President Kennedy in the 1960s created the right to form federal unions; I wonder if it is challenged legally if that challenge might be overturned?

#### **APRIL 2025 MEETING MINUTES**

NARFE Roanoke Valley Chapter 0111, Area VII, met on Friday, April 4, 2025 at Olive Garden. Frances Boatman, President, conducted the meeting. The meeting was called to order at 12:02 p.m. with 19 people in attendance including our guest speaker. There was one new member in attendance. A quorum was present to conduct chapter business.

April birthdays were recognized.

Frances led us in the Pledge of Allegiance.

The Secretary's minutes for the March 2025 meeting were approved as published; motion made by Ruth Greene, seconded by Karen Willis. Motion approved by acclamation.

Ellie Long, Secretary, reported one former member death; offered "Be Prepared for Life's Events" booklets; and distributed the updated Trifold Quick Guide to NARFE/VANARFE websites and social media accounts.

Ellie gave the Treasurer's report and gave an update on Mark; he's doing well. The Board approved the CY2025 Chapter budget. We spent about half of what we had last year and will be on a tighter budget this year.

Frances gave the membership report. Currently, there are 163 chapter members. Since January our chapter has gained 15 new members! Welcome new members **Ronald Gordon** and **Cheryl Ponce**!

Karen Simmons, 2<sup>nd</sup> VP, mentioned our May, August and September programs. Our August speaker will discuss The Bedford Boys and our September speaker is from the Roanoke Valley Bird Club.

Bill Ketron, Legislative Chair, gave the Legislation report.

Ruth Greene, Area VII VP, asked for any volunteers to serve as the next Area VII VP. If you want to contribute to the cost of the chapter's Conference Alzheimer's basket, Ruth will collect contributions.

Frances gave the President's report.

Ruth inquired if anyone would be interested in another Virginia Dare Cruise in July. There was interest and she will check dates available.

Frances asked for a motion to spend \$50 for the chapter Alzheimer's basket. Karen Willis made the motion, Phyllis Scruggs seconded. Motion approved by acclamation.

Phyllis will donate the raffle basket for the May meeting; Ellie will donate the raffle basket for the August meeting.

Our guest speaker was Dawn Sandoval, founder of The Least of These Ministry.

<u>The Least of These Ministry (TLOT)</u> is a non-profit organization that strives to make a positive difference in the

lives of the homeless community in the Roanoke Valley. Its mission is to meet men and women living on the streets and serve them with spiritual, physical, and emotional support. There are many circumstances that can bring a person to homelessness like job loss, natural disasters, mental illness, and more. Many homeless people receive disability checks but their income isn't enough to cover minimum living expenses. Many suffer from social anxiety and mental health issues that make it difficult to live in a shelter environment. Operating as a gap ministry, we work to meet needs that other homeless services in the area are unable to meet. Services we provided vary from assisting in finding housing, meeting immediate needs on the streets and providing a place to improve hygiene. Specifically, we 1) Assist eligible homeless friends in finding and securing affordable housing. 2) Address immediate needs on the streets through the ministry ambulance "Mercy Grace." Items such as cold weather gear, tshirts, socks, hygiene items, sleeping bags, snacks, and more are provided when needed. 3) Open our building at 422 Luck Ave. Monday, Wednesday and Friday from 12:30 p.m. to 4:30 p.m. and allow unsheltered friends to take a shower. Soaps. razors, towels, and wash cloths are provided when needed. Showers are cleaned in between each use. Coffee, lunch and refreshments are offered while they wait. 4) Provide outdoor covered lockers in the parking lot next to its facility so homeless friends can store their personal belongings safely. We also provide combination locks. 5) Provide a place of refuge during nights when temperatures are below 40 degrees through two "warming buses." Stocked with blankets and snacks, the warming bus offers warmth, safety, and a place to get some rest in extreme temperatures. 6) Operate a former motel that provides affordable housing by the week or month. 7) Partner with multiple agencies and property managers to locate temporary or permanent housing. We always need volunteers and we accept donations.

The 50/50 (Alzheimer's Fund) drawing was won by Phyllis Scruggs. The basket drawing was won by Eileen Bartels Hadden.

The meeting was adjourned at 1:11 p.m.
